

4.	Fire Safety Undertaking, the school shall submit a Fire Safety Certificate in the prescribed format (APPENDIX - XII) of Circular No. 12/2022 dated 14.10.2022 available on the Board s website or as issued by a Competent Govt. Authority.
5.	Safe Drinking Water and Sanitation Certificate as per the format (APPENDIX - XIII) of Circular No. 12/2022 dated 14.10.2022 available on the Board's website.

# B. The school shall ensure the availability of the following infrastructure & facilities in the schools within 02 years of grant of affiliation:

1. Ramps at the entrance(s) as well as Ramps/lifts for CWSN, to access the upper floors of the school (in case of a multistoried school) (Circular No. CBSE/AFF-05/2023 dated 06.03.2023).

- Separate toilets for CWSN, boys and girls and these should be provided on every floor (in case of multistoried schools) (Circular No. CBSE/AFF-05/2023 dated 06.03.2023).
- 3. Boundary Wall: Concrete boundary wall of not less than 6 ft. height, enclosing the school campus/site. Composite boundary walls which are partly concrete and partly grill/mesh/barbed wire below 6 feet will not be acceptable. If fencing/grill is required, then the same should be over and above 6 feet height.
- Appropriate laboratory infrastructure for Secondary School (Composite Science Lab, Mathematics Lab, Computer Lab) and for Senior Secondary School (Composite Science Lab, Mathematics Lab, Computer Lab, Physics Lab, Chemistry Lab, Biology Lab.) (Circular no. CBSE/AFF-11/2022 dated 04.10.2022).
- 5. Well stocked library with adequate reading area. (Circular no. CBSE/AFF-11/2022 dated 04.10.2022).
- 6. Well-developed indoor and outdoor sports facilities. (Circular no. CBSE/AFF-11/2022 dated 04.10.2022).
- 7. Well-developed Digital Infrastructure (Circular No. CBSE/AFF-10/2023 dated 24.03.2023).
- An operational website of the school may be ensured and upload Mandatory Public Disclosure As per appendix-IX of Circular No. 09/2021 dated 21.05.2021 and provide the revised link of the same.
